

**2010 Annual Meeting of the Town of Onalaska  
Town Hall  
April 13, 2010**

Fifty-five town residents signed in at the beginning of the meeting. Frank Fogel and Sandy Thompson were sworn in to office prior to the meeting. Additional supervisors present were Paudler, Steve Michaels, Marc Schultz, and Clerk Sue Schultz.

Sandy Thompson made a motion to approve the agenda.  
Stan Hauser seconded the motion. Motion passed on a hand voted 55 for to 0 against.

Howard Kelly made a motion to approve the 2009 Annual Meeting Minutes.  
Steve Michaels seconded the motion. Motion passed on a hand vote 55 for to 0 against.

Mike Temp of Tostrud & Temp gave the 2009 financial report. Howard Kelly made a motion to approve the 2009 financial report.

Vicki Burke made a motion to approve the Stormwater 2009 Financial Report. Howard Kelly seconded the motion. Motion passed 52 to 0.

Joe Schaller made a motion to set Emergency Borrowing Authority for the Town Board in the amount of \$40,000, the same as last year. Howard Kelly seconded the motion. Motion passed on a hand vote 42 for to 2 against.

Bill Gingerich made a motion to approve the donations of YMCA for \$3,000 and Holmen Area Partnership for Youth (HAPY) for \$3,000. Tammy Addleman seconded the motion. Motion passed on a hand vote 44 for and 0 against.

Marc Schultz made a motion to set the 2010 Annual Town Meeting date as April 12, 2011. Joe Schaller seconded the motion. Motion passed on a hand vote 47 for and 0 against.

Dan Filzen made a motion to approve Highway Expenditures for the 2010 Seal Coating and Crack Filling in the amount of \$140,000.

Howard Kelly seconded the motion. A list of roads to be seal coated are; Green Coulee Road, Green Coulee Lane, Clifford Drive, Wood hollow Road, Superior Street, Ruth Lane, Koss Road, Aspen Road, Moss Road, Wend land Road, Trussing Court, Oakwood Drive, Hauser Road, Abet Road, Schick Road, Eagle Circle Lane, Schultz Lane and Sobkowiak Road

Chairman Paudler thanked town citizen Gary Shuttle for acting as parliamentarian at this meeting and Mike Temp for presenting the Town Financial Report.
