# Town of Onalaska Town Board Meeting Minutes

Supervisor Schultz made a motion to approve the agenda. Supervisor Fogel seconded the motion. Motion passed unanimously.

Supervisor Michaels made a motion to approve the November 8, 2011 Meeting Minutes, October 12, 2011 Special Meeting Minutes and the November 15, 2011 Special Meeting Minutes. Supervisor Schultz seconded the motion. Motion passed unanimously.

Supervisor Michaels made a motion to approve the bills. Supervisor Fogel seconded the motion. Roll call vote, motion passed unanimously.

## Citizen's Concerns:

Beverly Brady, N6378 County Road XX, Holmen, states that the Holmen School Board, Town of Holland, Town of Farmington, and City of La Crosse is expected to make a recommendation on the CAPX2020. Would like Town of Onalaska to make a recommendation.

### **New Business:**

Supervisor Michaels made a motion to allow funds in the joint maintenance reserves to be donated in the amount of \$6,000 to the Holmen Foundation to complete the last link of the trail located in Town of Onalaska as long as no other projects are expected. Supervisor Schultz seconded the motion. Roll call vote: Fogel-nay, Schulzt-aye, Michaels-aye, Thompson-aye. Motion carries 3-1.

Supervisor Michaels made a motion to approve the OSHA clothing for the town crew to comply with state regulations. Supervisor Schultz seconded the motion. Roll call vote, motion passed unanimously.

Power point presentation was presented by John Haese. Supervisor Schultz recommended UW-extension or a graduate student to address ash trees in the parks. Supervisor Michaels said the park committee would meet and report back at the February meeting.

Supervisor Michaels made a motion to approve the no parking signs on Clifford Drive in Onalaska November thru April and to have the info added to the sign ordinance. Supervisor Fogel seconded the motion. Roll call vote, motion passed unanimously.

Supervisor Schultz made a motion that the Clerk be authorized to accommodate individual requests to have agendas emailed; that the agendas have the disclaimer that this is a courtesy and is subject to change. Supervisor Michaels seconded the motion. Roll call vote, motion passed unanimously.

Park Bank sent a letter thanking the Town for opening the Bank Account for Tax payments.

Jeff Bluske sent an email in regards to the sign going up at US Fish and Wildlife. There was some miscommunication somewhere along the way with the contractors. They will be attending the Plan Commission and Town Board Meetings in January.
