Nikolaos Stoufis has the right to demand that the evidentiary hearing or meeting be held in open session. This paragraph and Wis. Stat. Section 19.85 (1) (f) do not apply to any such evidentiary hearing or meeting where the employee or person licensed requests that an open session be held.
