Hauser made a motion to approve the agenda, Shefelbine seconded the motion. MPU

Shefelbine made a motion to approve May 5, 2015 meeting minutes. Bogert seconded the motion. Motion passed unanimously.

Hauser made a motion to approve the bills and finance book with the addition of Rudy's bill of \$210.00. Shefelbine seconded the motion. Motion passed unanimously.

Discussion on sink hole for Marie Mitchell N5643 Cheyenne Drive, Onalaska, tax parcel 10-2532-0. Shefelbine made a recommendation to get permits from the DNR and La Crosse County to repair the sink hole for Marie Mitchell. Hauser seconded the motion. Motion passed unanimously.

Discussion on Storm Water Budget. No action.

Discussion on Apple Blossom Trail culvert project. Hauser made a recommendation for the town crew to do the Apple Blossom Trail culvert project. Shefelbine seconded the motion. Motion passed unanimously.

Discussion on Grey Hawk Inlet project. Shefelbine made a motion to recommend the town crew to do the Grey Hawk Inlet project. Hauser seconded the motion. Motion passed unanimously.

Discussion on McCurdy Road sinkhole. Hauser made a motion to recommend the town crew to replace the culvert and repair the sinkhole on McCurdy Road. Shefelbine seconded the motion. Motion passed unanimously.

Motion to convene into closed session pursuant to Wis Stat. Sec. 19.85 (1) (g) conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved. Hauser made the motion @7:02pm. Shefelbine seconded the motion. Roll call vote. Motion passed unanimously.

Hauser made a motion to reconvene into open session @ 7:43 p.m. Shefelbine seconded the motion. Roll call vote. Motion passed unanimously.

Shefelbine made a motion to recommend referring the issue to mediation. Hauser seconded the motion. Roll call vote. Motion passed unanimously.
