**Discussion in regards to HotJet USA, culvert jetter proposal for \$71,510.20:** No action.

**Discussion on repair of Ruth Lane cul-de-sac:** Chairman Bogert will have General Engineering assess the cul-de-sac and report back with what repairs may be needed.

**Discussion on purchase and installation of guard rails at near intersection of Park Drive and Schilling Road:** Motion by Schultz; seconded by Shefelbine to recommend approval of the portion of the Smith Restoration proposal relating to Park Drive at Schilling Road for the installation of guard rails with terminal ends. Motion passed unanimously.

**Discussion on appointment of Tim Reagles to fill vacancy on Storm water Utility Committee:** Motion by recommend appointment of Tim Reagles to Storm Water Committee by Hauser; seconded by Shefelbine. Motion passed unanimously.

**Motion to adjourn** by Schultz; seconded by Shefelbine passed unanimously at 8:08 pm.
